CONTRACT FOR SPRING/COUNTRY FAIR

I hereby reserve _____space(s) for the ___SPRING FAIR ___COUNTRY FAIR sponsored by the Friends of the Adornos, for the benefit of the Adorno Fathers of Ramsey, N.J.

SPRING FAIR: SUNDAY, MAY 16, 2010 (RAIN DATE: SUNDAY, MAY 23, 2010)
COUNTRY FAIR: SUNDAY, OCT. 10, 2010 (RAIN DATE: SUNDAY, OCT. 17, 2010)

The Fair will be held on the grounds of the Adorno Fathers at 575 Darlington Ave. Ramsey, N.J. from 10:00 a.m. to 6:00 p.m.

- 1) Spaces are 20x20 feet. The merchant agrees to donate to the Friends of the Adornos a fee in the amount of \$60.00 (Prime Spot \$75.00). For Prime spots numbers see attached letter. *Donations made within 30 days of the date of the Fair must be made in cash, money order or certified check.* An additional \$10.00 will be charged on the day of the Fair. Any Merchant requiring electricity will be charged an additional fee of not less than \$10.00.
- 2) The Friends of the Adornos agree to publicize the event with ads in local newspapers, posters and flyers at appropriate locations.
- 3) **The Friends of the Adornos and the Adorno Fathers reserve the right to refuse merchants who carry merchandise, products or services that are contrary to or are in conflict with our goals, value system or beliefs. We further reserve the right to limit same-item merchants or merchants providing services only at our discretion.**
- 4) Merchants will supply their own tables, display racks, etc.
- 5) Cancellations made one month (30 days) prior to the Fair will be refunded in full. \$30.00 will be refunded up to 15 days prior to the Fair. Any cancellations 14 days or less prior to the Fair are not refundable.
- 6) Sale of firearms, ammunition, pornographic and related materials, nuisance items such as firecrackers, water pistols etc. are prohibited. Non compliance with these requirements will result in the forfeiture of right to sell. There will be no refund.
- 7) The Friends of the Adornos reserve the right to sell any food and beverage, and to charge additional fees for any concession permitted to sell such items.
- 8) Each merchant is required to clean up his/her spot at the end of the day and to remove all refuse, boxes and papers, and place them in the garbage bin located at the rear of the Adorno Center. The spaces must be left as found in the morning. Those who do not comply with this rule will prejudice his/her privilege for the next Fair.
- 9) Set up time on the day of the Fair is between 6:00 a.m. to 8:00 a.m. No one is allowed on the grounds before 6:00 a.m. No one is allowed to drive his vehicle to the spot after 8:00 a.m. Please keep the walkway clear before 8:00 a.m. No oversized vehicle will be allowed in the Fair grounds.
- 10) The Adorno Fathers or the Friends of the Adornos will not assume any responsibility for any theft or damage to objects displayed or to personal property.
- 11) This contract is not transferable.
